FILING ERRATA TO THE TESTIMONY OF WITNESS PAGE (USPS-T-23)  
[ERRATA]

The United States Postal Service hereby gives notice of the filing of errata to the testimony of witness Page (USPS-T-23). The errata arise from various sources, including other witnesses, discovery responses, and the witness' own reviews. Most of the errata are in various tables, in which case each change is highlighted by gray shading and the name of each table also reflects the fact of revision. One set of changes (deletions) affects pagination; the Postal Service is accordingly providing a complete, revised copy of the testimony.

The marking and highlighting of changes permits participants to review the final version of the testimony and see what has changed. Changes include:

Table 3B, page 8, Test Year Delivery Confirmation Unit Volume Variable Costs, Delivery Confirmation, right hand column, has changes to the column for Parcel Select Electronic to two values. Correction of a transposition error changes the value \$0.1467 to \$0.1476 in both places.

Table 8, page 15, Test Year Unit Volume Variable Costs for Return Receipts, has a change for Return Receipts, Non-Merchandise, with the cost increasing from \$1.46 to \$1.55.

For return receipts, the reference to new "window transaction times" on page 14, lines 17-18, is deleted, because the revised cost study relies solely on the window transaction times used in previous dockets. Moreover, the last two sentences of the third paragraph of section B, on pages 14-15, are deleted, because different sources for traditional and electronic transaction times are no longer used.

Table 13, page 27, Summary of Final Adjustments has changes throughout the table.

Table 14C, page 29, contains changes for Confirm's volume variable costs and total incremental costs.

Table 15, page 31, contains changes for non-merchandise Return Receipt.

Table 17, page 33, Summary of Final Adjustments by Cost Segment, has changes throughout the table.

Each of the changes identified above (except for deletions) is marked “Revised on 8/11/06” or “Revised on 8/11/2006” (the date on which the errata were expected to have been filed, as reflected in the response to DFC/USPS-T23-23). In recognition of the actual revision date, a footer has been added to the PDF form of the testimony indicating on all pages today’s date.
