PRESIDING OFFICER'S RULING ADJUSTING  
SCHEDULE OF REBUTTAL WITNESSES' APPEARANCES

(Issued November 27, 2006)

Two motions have been filed requesting adjustments to the schedule of the November 29 — December 7, 2006 hearings in this docket. They are a Motion of the United States Postal Service to Reschedule the Appearance of Postal Service Witness Laws, filed November 21, 2006, and National Association of Presort Mailers Motion to Change Order of Appearance of Witness Bell (NAPM-RT-1) at December 6 Hearing, filed November 22, 2006.

Both motions are granted. Witness Laws is scheduled to appear to testify on December 7, instead of December 1. Witness Bell is scheduled to testify first on December 6.

Additionally, the late-filed Notice of American Business Media of Witness Availability ABM/RT-1 and ABM/RT-2 (Notice) indicates a conflict. The two American Business Media witnesses are currently scheduled to appear December 7. The late-filed Notice indicates they will be unavailable on that date. I will reschedule witnesses Bradfield (ABM-RT-1) and McGarvy (ABM-RT-2) to appear last on December 4, 2006.

RULING

1. The Motion of the United States Postal Service to Reschedule the Appearance of Postal Service Witness Laws, filed November 21, 2006, is granted.
2. National Association of Presort Mailers Motion to Change Order of Appearance of Witness Bell (NAPM-RT-1) at December 6 Hearing, filed November 22, 2006, is granted.
3. The appearance of American Business Media rebuttal witnesses is rescheduled.
