**CONSENT MOTION FOR EXTENTION OF TIME TO FILE MOTIONS TO COMPEL  
RELATED TO THE DOCUMENTS REQUESTS AND INTERROGATORIES OF  
CAPITAL ONE SERVICES, INC.**

(August 29, 2008)

Capital One Services, Inc. (Capital One) served interrogatories and document requests on the United States Postal Service on August 8, 2008. See COS/USPS-1-11, COS/USPS-DR-1-17. The Postal Service filed objections to those discovery requests on August 18, 2008, and August 19, 2008, respectfully. By application of the Commission's rules, motions to compel are due by Tuesday, September 2, 2008.

The deposition testimony of Ms. Jessica Dauer Lowrance occurred on August 27-28, 2008, and that deposition testimony sheds light on Capital One's discovery request. As that deposition transcript will not be ready until approximately September 2 or 3, 2008, Capital One respectfully requests that it be allowed to file motion to compel within one week from the time the transcript is made available—*i.e.*, by Wednesday, September 10, 2008. Counsel for the Postal Service has said it does not oppose this motion.
