**UNITED STATES POSTAL SERVICE FILING OF UPDATED SCHEDULE FOR  
REGULAR AND PREDICTABLE RATE ADJUSTMENTS**  
(December 29, 2025)

Rule 3030.102 requires the Postal Service to maintain a Schedule for Regular and Predictable Rate Adjustments with the Postal Regulatory Commission. Consistent with Rule 3030.102, the Postal Service hereby files its updated Schedule, as appended hereto. As indicated therein, and subject to the approval of the Governors, the Postal Service presently intends to next adjust Market Dominant prices in July 2026.

As required by Rule 3030.102, the appended Schedule provides estimated filing and implementation dates for future rate adjustments over the next three years and provides information sufficient to predict the amounts of those future rate adjustments. In addition, the Postal Service plans to file updated pricing schedules each year when it publishes its Annual Compliance Report in December.

Please note that there are multiple pending proposals from both the Commission and the Postal Service in Docket No. RM2024-4, Review of the System for Regulating Rates and Classes for Market Dominant Products. Some of those proposals contemplate limiting the rate adjustments covered by this Schedule to once a year. Naturally, if any of the aforementioned proposals are adopted, during the time period

covered by this schedule, the Postal Service will likely need to make adjustments to this schedule as contemplated in 39 CFR §3030.102(c). For now, in compliance with the currently applicable regulations, the Postal Service, for the purposes of this schedule, intends to continue with the practice of implementing up to two price changes a year.

**Schedule for Regular and Predictable Rate Adjustments – Effective through  
Calendar Year 2028**

Subject to the approval of the Governors, the Postal Service presently expects to implement price changes for all Market Dominant classes in July 2026, with the filing occurring in April 2026. Given our current financial condition, the Postal Service anticipates that the price change for each Market Dominant class may require applying most or all pricing authority available on the date of filing.

Likewise, subject to the approval of the Governors, the Postal Service expects that, in each subsequent year, it will implement price changes for all Market Dominant classes in January and July of such year, with the filings occurring the preceding October and April, respectively. Depending on our financial condition, the Postal Service anticipates the possibility that the price adjustment for each Market Dominant class may require applying most or all pricing authority available at the time of filing.
